CAN TAKE

Bricks, Concrete, Roofing materials, Soil, Rock, Wood, Wall and Floor covering, Plaster, Drywall, Plumbing fixtures, Electrical components containing no hazardous materials, Non asbestos insulation, Construction packing no more than 10% of the load.

CAN NOT DUMP

Friable Asbestos, Garbage, ~~Furniture~~, Appliances, Electrical equipment containing hazardous materials, Tires, Drums and Containers, Gas cans, Paint cans metal or plastic, 5 Gal. buckets metal or plastic, Roofing cement cans, Caulking tubes, any kind of Aerosol cans, Oil cans, Antifreeze jugs, Pesticide containers, Railroad ties, Electric poles, any Creosote treated lumber, Household trash meaning ~~Mattress, Box Springs, Cloths, Dishes, Bedding of any kind, TV's, Papers~~, Books, Canned Food, Cleaning supplies.
